ARTICLE I - NAME

THE NAME OF THIS CORPORATION IS: J.C. CHANTEL CONCRETE CORP.

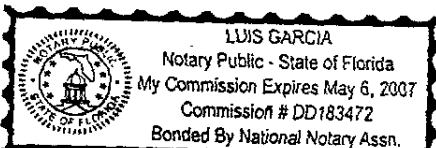
