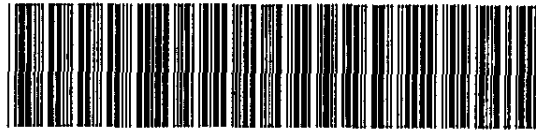





2. These Articles of Amendment were approved by the shareholders of the corporation by vote and the number of votes cast for the amendments by the shareholders was sufficient for approval.


3. The name of the corporation is DUVAL TAXI INC.
