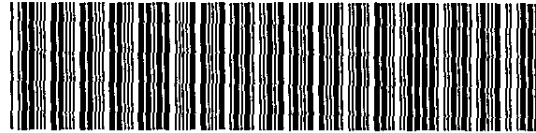



OF

ARTICLE I - NAME

The name of the Corporation shall be VAUGHT AND SONS
CONSTRUCTION, INC.

ARTICLE II - EXISTENCE

The Corporation shall have perpetual existence and its
existence shall begin business upon the approval of these Articles
of Incorporation by the Secretary of State.

ARTICLE III - PURPOSE

ARTICLE VII - ANNUAL MEETING


The annual meeting of the corporation shall be held on the second Friday of June of each year. The annual meeting shall be held at the corporation address and such other place as may be designed by its officers.




