ARTICLES OF INCORPORATION**OF****DORNING INC.****ARTICLE I**

The name of the corporation is DORNING INC., (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 9595 Collins Avenue, Unit 404(N), Surfside, Florida 33154.

ARTICLE III

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.
