ARTICLES OF INCORPORATION OF

ARTICLE 1. - NAME

The name of the Corporation is Our Cleaning Touch, Inc..

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the Corporation shall initially be at 18414 Van Nuys Circle, Port Charlotte, Florida 33948-9572. The Corporation may change its principal office from time to time as permitted by law.
