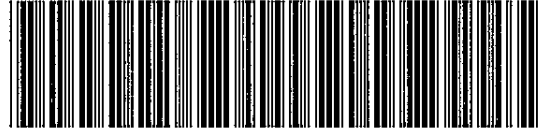

We, the undersigned, hereby make, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I
Name of Corporation

The name of the Corporation shall be STAFFAN H. LUNDBERG ARCHITECT, INC.. The address is 1925 20th Street, Vero Beach, Florida 32960.

ARTICLE II
Purpose of Business

The Corporation is organized for the purpose of providing architectural services under the laws of the United States or of this State.

ARTICLE III
Capital Stock

The capital stock of this Corporation shall consist of 1,000 shares of common stock of \$1.00 par value, fully paid and non-assessable. The whole or any part of the capital stock of this Corporation may be paid for in lawful money of the United States of America or in property, labor or services at a just valuation to be fixed by the Directors.

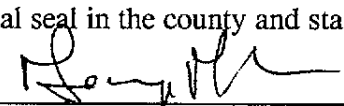

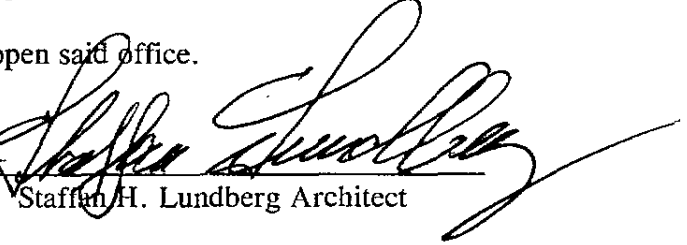
