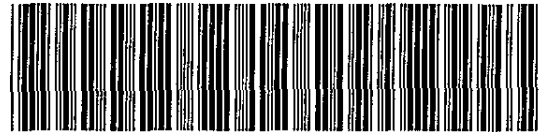



**ARTICLES OF INCORPORATION  
OF**

**Jan-Cee, Inc.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the Laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be **Jan-Cee, Inc.**

**ARTICLE II**

This Corporation shall commence its existence upon filing these articles, and shall exist perpetually unless dissolved in accordance with the Laws of the State of Florida.

**ARTICLE III**

The corporation may engage in any activities of business permitted under the Laws of the United States and of this State.

**ARTICLE IV**

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is ONE THOUSAND (1000) shares of common stock at One Dollar (\$1.00) par value. All or any part of said stock of this Corporation may be paid for wholly or in part for cash or other property, excluding stock or other securities, at a just valuation to be fixed by the Directors of this Corporation at any regular or special meeting and any and all shares so issued shall be fully paid and nonassessable.

**ARTICLE V**

The initial street address of the principal office of this Corporation in the State of Florida is: 1061 Howell Harbor Drive, Casselberry, Florida 32707. The Board of Directors may from time to time move the principal office to any other address in Florida. This corporation shall have the privilege of having such branch offices at such other places within the State of Florida as may be designated from time to time by the Directors of the Corporation.

**ARTICLE VI**

This corporation shall have ONE (1) Director initially; the number of Directors may be increased from time to time in accordance with the By-Laws adopted by the Stockholders, but shall never be less than ONE (1).


