Greetings and thank you for your time. I am sending you this letter with our report and check for \$150.00, in hopes that you'll waive the \$400.00 late fee when I try and explain what happened.

A few weeks ago I called your office to get some information on making name changes to our company name and was given the website address. While trying to pull up the amendment forms, I noticed the Annual Report notification.

I called your office again and was told that I was supposed to send the Annual Report back by May 1st with \$150.00 and that I should have gotten a card in the mail. When I told the lady I didn't receive a card, she said to send the \$150.00 with a letter and if approved, the \$400.00 late fee would be waived.

Since I've been having more trouble than usual with my mail this past year, I finally went to the Post Office last week to find out if something was wrong. I thought the mail problems were still from last year's hurricanes, the anthrax scares and this year's growth boom.
