Section 655.922, Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banc," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union" in its corporate name.

Therefore, this Office will not object to the use of the above referenced name being registered to transact business in the state of Florida. However, If the proposed bank holding company is not organized, we will require that the corporation be dissolved or the name changed.

# THIRD AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

## CNBS FINANCIAL GROUP, INC. a Florida corporation

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

- 1. The name of the Corporation is CNBS FINANCIAL GROUP, INC. (the "Corporation").
- 2. Article I of the Articles of Incorporation is amended to read in its entirety as follows:

#### ARTICLE I - NAME

### The name of the Corporation is HomeBancorp, Inc.

- 3. The foregoing amendment was adopted by the directors of the Corporation at a meeting on April 16, 2008. The shareholders of the Corporation approved and adopted the foregoing amendment at a meeting on May 21, 2008. The number of votes cast for the amendment by the shareholders was sufficient for approval.
