ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is Polele Investment, Inc. (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1865 Brickell Avenue, Apt. A-612, Miami, Fl 33129.

ARTICLE III

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.

ARTICLE VII
