**ARTICLES OF INCORPORATION**  
**OF**  
**SAN MARTIN DE LAS ALEGRÍAS, INC.**

**ARTICLE I**

The name of the corporation is San Martin de Las Alegrias, Inc. (the "Corporation").

**ARTICLE II**

The address of the principal office and the mailing address of the Corporation is 1100 Brickell Avenue, Suite 609, Miami, FL 33131.

**ARTICLE III**

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

**ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of all votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

**ARTICLE V**

The street address of the Corporation's initial registered office is 103 North Meridian Street, Lower Level, Tallahassee, FL 32301 and the name of its initial registered agent at such office is CorpDirect Agents, Inc.

**ARTICLE VI**

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.

**ARTICLE VII**

The name of the Incorporator is Nora H Hernandez and the address of the Incorporator is 1221 Brickell Avenue, Miami, FL 33131.

**ARTICLE VIII**


This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
