ARTICLES OF INCORPORATION OF MAYFLOWER OFFICE MANAGERS, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of incorporation for the purpose of creating a corporation under the laws of the State of Floride:

 NAME. The name of this corporation (the "Corporation") and the principal office and mailing address of the Corporation is:

- 2. <u>PURPOSE</u>. The corporation is organized for the purpose of acting as Property Manager of the property known as *Mayflower Center, Inc.*, 222 South West Monte Drive, Altamonte Springs, Florida, (referred to herein as the "Property"), and for transacting any and all lawful business permitted by the laws of the State of Florida, necessary and appropriate to accomplish the foregoing.
- 3. <u>CAPITAL STOCK.</u> This Corporation is authorized to issue One Thousand (1,000) shares of One (\$1.00) Dollar par value common stock, which shall be designated as "Common Shares."
