

# ARTICLES OF INCORPORATION OF MAYFLOWER OFFICE ADVISORS, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of incorporation for the purpose of creating a corporation under the laws of the State of Florida:

 NAME. The name of this corporation (the "Corporation") and the principal office and mailing address of the Corporation is:

- 2. PURPOSE. The corporation is organized for the sole purpose of acting as Manager and a 0.5% owner of MAYFLOWER OFFICE INVESTORS, LLC (the "LLC"), in connection with, (I) owning, holding, seiling, leasing, transferring, exchanging, operating and managing the property known as Mayflower Center, Inc., 222 South Westmonte Drive, Attamonte Springs, Florida, (referred to herein as the "Property"), (ii) entering into loan documents with Bank of America, N.A. (The "Lender") for the acquisition of the Property. Subject to the restriction below, the Corporation shall indemnify any officer or director or any former officer or director, to the fullest extent permitted by law either now existing or hereafter enacted. Notwithstanding the foregoing this obligation to indemnify directors and officers is subordinate to the loan in favor of Lender and shall not constitute a claim against the Corporation in

the event that cash flow in excess of amounts necessary to pay holders of the loan is insufficient to pay such obligations.

- CERTAIN ACTIONS REQUIRING UNANIMOUS VOTE. The unenimous vote of the Corporation's shareholders shall be required in order to take any of the following actions on behalf of the Corporation or the LLC:

#### 10. SEPARATENESS PROVISIONS: The Corporation shall not:

- fail to observe all organizational formalities, or fail to preserve its existence as an entity duly organized, validly existing and in good standing under the laws of Florida, or amend, modify, terminate or fail to comply with the provisions of its organizational documents;
- c. own any subaldiary, or make any investment in, any other entity;
- d. . commingle its assets with the assets of any other entity;

- guaranteeing any obligation), other than (A) the loan from Lender, (B) trade and operational indebtedness incurred in the ordinary course of business with trade creditors, provided such indebtedness is (1) unsecured, (2) not evidenced by a note, (3) on commercially reasonable terms and conditions, and (4) due not more than sixty (60) days past the date incurred, and/or (C) financing leases and purchase money indebtedness incurred in the ordinary course of business relating to personal property at the subject mortgaged property on commercially reasonable terms and conditions; provided however, the aggregate amount of the indobtedness described in (B) and (C) shall not exceed at any time three percent (3%) of the outstanding principal amount of the loan from Lender,

- j. make any loans or advances to any entity;
- k. fail to file its own tax returns;
