ARTICLES OF INCORPORATION
of

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is **Done Wright Renovations Corp.**, and the street address of the principal office of the corporation is 835 41st Avenue North, St. Petersburg, Florida 33703.

ARTICLE II - DURATION; EFFECTIVE DATE

This corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation.


ARTICLE VI - INCORPORATORS


