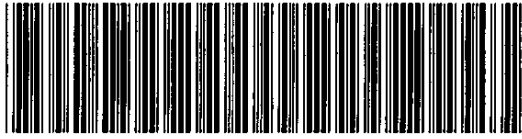


**The name of the new Registered Agent and President is Lina Trinh, residing at 3137 Mccwan View Circle, Orlando, FL 32812**
