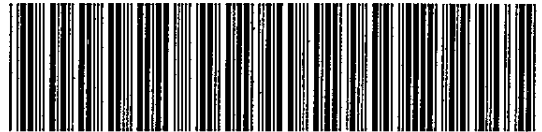

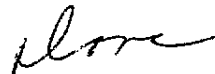

I, THOMAS J. RUDDY, being of legal age do hereby authorize the formation of a corporation under the laws of the State of Florida.

ARTICLE I.

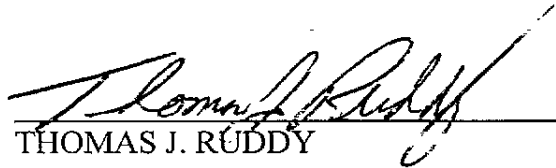
