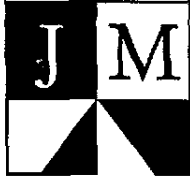

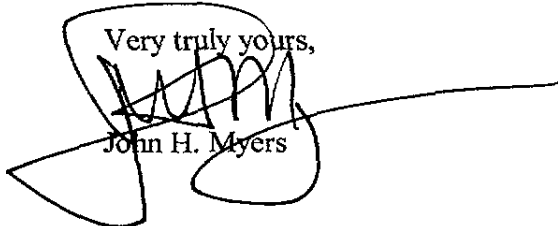

**ARTICLES OF INCORPORATION
OF
TREEMAN CORPORATION**

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

NAME

The name of this corporation is Treeman Corporation.

ADDRESS

The physical location of the corporation shall be at 15 Crossroads, Suite 251, Sarasota, FL 34239.

TERM

This corporation shall exist perpetually.

PURPOSE

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Florida law.

STOCK
