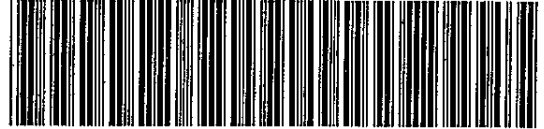

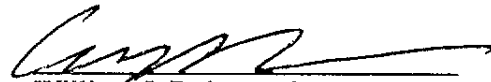

**ARTICLES OF INCORPORATION  
OF  
LIZA'S ORIENTAL STORE, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation.

**ARTICLE I - NAME**

The name of the corporation is Liza's Oriental Store, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

**ARTICLE III - PURPOSE OR PURPOSES**
