ARTICLE I. CORPORATE NAME

The name of this corporation is Sky Lake Irrigation, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of providing service and installation of irrigation systems, and contractually related services, along with any and all other business permitted under the laws of the United States of America and the great state of Florida.

ARTICLE III. CAPITAL STOCK
