ARTICLE I - NAME

The name of this corporation shall be JIM THE DOOR SPECIALIST, INC., and the address of the principal office of the corporation is 1220 19th Street, Orange City, Florida 32763.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business.


