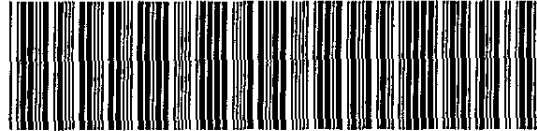

ARTICLE I - NAME

The name of this Corporation is JOE'S PAVERS, INC.




