CERTIFICATE OF INCORPORATION

We undersigned, hereby associated ourselves together for the purpose of becoming a corporation under the laws of the State of Florida by and under the provisions of the statutes of the State of Florida, providing for the formation, rights, privileges, cimmunities and liabilities of incorporation for profit.
