
To Whom It May Concern:

I am writing this letter pursuant to the instructions of Kathy of your office in order to request a waiver of the \$400.00 late fee for the filing of my firm's Annual Report. I am the only employee of my firm and, for personal reasons explained below, I have been doing very little work since the beginning of the year and have not been able to get to my office very much. In fact, I have not worked at all since the end of April 2008 when both my father and my daughter were sick and in the hospital. My father was diagnosed with esophageal cancer at the very end of last year and started chemotherapy and radiation therapy in January. He lives in Baltimore so I went up there to help my parents. Then in April 2008, while my father was recovering from his chemo and radiation, my 13-year-old daughter passed out and broke her jaw. I spent four days in the hospital with my daughter and then at home caring for her for another few weeks. I have been taking her to doctors since that time to find out why she has been passing out. As soon as she went back to school, I went back up to Baltimore to be with my parents while my father underwent complicated surgery. As a result, I did not pay much attention to my business other than to pay my bills from mid-March until last week when I finally went back to my office.

Last week, I found the Notice of Intent to Dissolve in my mail. A few days later, I finally found the Annual Report Notice slipped amongst industry newspapers and publications in my office. So, I cannot say that I did not receive the Annual Report Notice, but, because of my personal circumstances, I did not receive it until late last week and phone the office immediately.

I am enclosing along with my firm's 2008 Annual Report, a check in the amount of \$158.75 to pay for its filing and a certificate of status. I would ask that you kindly waive the \$400.00 late fee for filing my firm's Annual Report at this late date due to my extenuating personal circumstances. Thank you for your kind attention to my situation.
