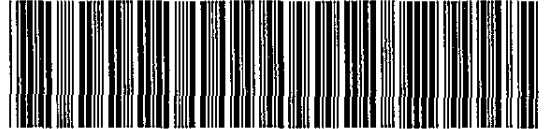

The corporation shall have no Directors and the business of the corporation shall be managed by the stockholders.


