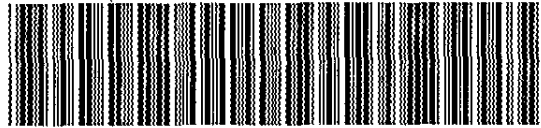

SECOND: The document number of the corporation: P04000086854


THIRD: The file date of the articles of incorporation was: June 3, 2004.
