**Articles of Incorporation**

**ARTICLE I – NAME**

The name of this corporation is **Darrelly's Marine Center, Inc.**

**ARTICLE II – DURATION**

This corporation is to have perpetual existence.

#### ARTICLE XIV – AMENDMENT





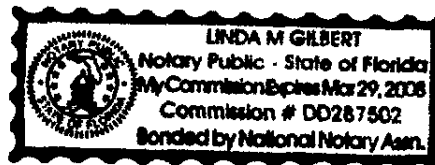
