ARTICLES OF INCORPORATION

OF

Mike Prilliman Realty, Inc.

The undersigned Incorporator does hereby adopt the following Articles of Incorporation under chapter 607 of the Florida Statutes, known as the Florida General Corporation Act:

ARTICLE I
(NAME AND ADDRESS)

The name of this corporation shall be **Mike Prilliman Realty, Inc.** ("Corporation"), and the address of the principal office of the Corporation shall be 38122-12th Avenue, Zephyrhills, Florida 33542.

ARTICLE II
(TERM)

The Corporation's existence shall commence upon the date of the filing of these Articles of Incorporation, and shall continue thereafter in perpetuity.

ARTICLE III
(PURPOSE)

The general purpose for which this corporation shall exist shall be to transact any or all lawful business permitted any corporation under the Florida General Corporation Act.

ARTICLE IV
(NUMBER OF AUTHORIZED SHARES)

The corporation shall be authorized to issue an aggregate of One Thousand (1,000) shares of common voting stock, each such share to have a par value of One Dollar (\$1.00), and all such shares being the same class.

ARTICLE V
(PRE-EMPTIVE RIGHTS)

All of the shareholders of this corporation shall be entitled to the benefits of preemptive rights with respect to any unissued or treasury shares of ownership of this corporation.

ARTICLE VI
(RESIDENT AGENT)

The street address of the initial registered office of the corporation shall be 38122-12th Avenue, Zephyrhills, FL 33542, and the initial registered agent for the Corporation shall be **Michael A. Prilliman**, whose business address is identical to the address of the registered office of the corporation.

ARTICLE VII
(BOARD OF DIRECTORS)

Initially, the corporation shall have a Board of Directors consisting of two (2) members whose names and addresses are as follows:

Michael A. Prilliman - P.O. Box 1015 - Zephyrhills, FL 33539-1015

Andrew J. Prilliman - 6402 Huntington Drive - Zephyrhills, FL 33542

The number of directors which shall constitute the Board may, from time to time hereafter,

be increased or decreased pursuant to any By-Law which shall have been enacted or more specifically ratified by an affirmative vote of the shareholders at any annual meeting or at any special directors meeting.

ARTICLE VIII
(THE INCORPORATORS)

The name and address of the Incorporator of this corporation is **Michael A. Prilliman**, of 38122-12th Avenue, Zephyrhills, Florida 33542.

ARTICLE IX
(THE OFFICERS)

The officers shall be a President and a Secretary/Treasurer. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

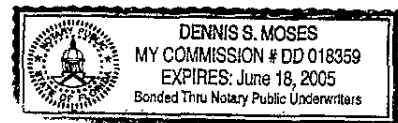

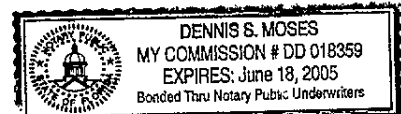
