#### ARTICLES OF INCORPORATION

OF

#### Mike Prilliman Realty, Inc.

The undersigned Incorporator does hereby adopt the following Articles of Incorporation under chapter 607 of the Florida Statutes, known as the Florida General Corporation Act:

### ARTICLE I (NAME AND ADDRESS)
