The undersigned, acting as the Incorporator of EQUES DEVELOPMENT CORPORATION, a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the *Florida Statutes*, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I - NAME**


**ARTICLE VIII - BYLAWS**


