ARTICLES OF INCORPORATION OF

ADVANCED MEDICAL IMAGING OF PINELLAS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ADVANCED MEDICAL IMAGING OF PINELLAS, INC.

ARTICLE II

The existence of the Corporation shall begin on June 1, 2004.

ARTICLE III

The street address of the principal office of the Corporation is 9555 Seminole Boulevard, Suite 101, Seminole, Florida 33772.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, no par, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V
