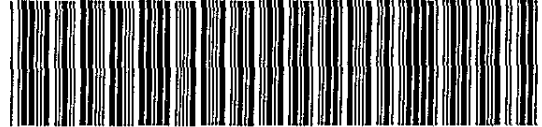

ARTICLES I - NAME

The name of the corporation shall be A. n R. Segarra, Inc.


ARTICLE IX - OFFICERS


