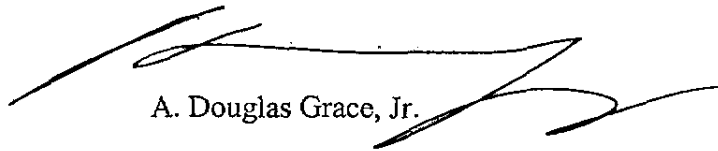

**ARTICLES OF INCORPORATION OF

I, the undersigned, hereby associate myself for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of SALAD SENSATIONS, INC., and hereby set forth and declare:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be SALAD SENSATIONS, INC.

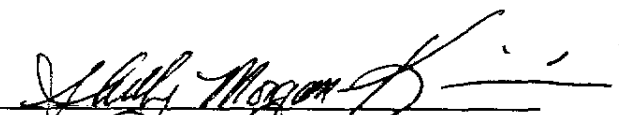

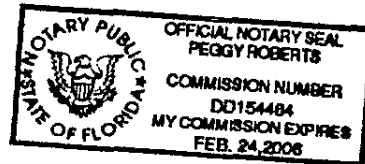
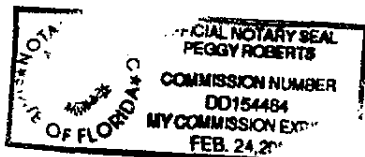
