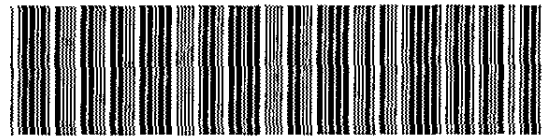

**ARTICLE I**

The name of this corporation is: **Scott LaCoste Construction, Inc.**

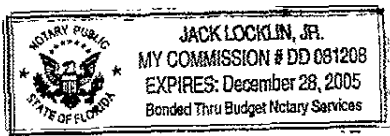
