1. The name of the corporation is BUZZMAN ROLLOUT AWNINGS OF DADE COUNTY, INC.

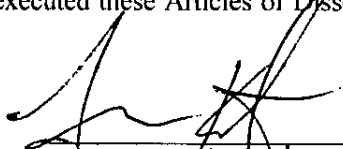
2. The Articles of Incorporation were filed on June 7, 2004, and the document number is P04000087815.
