**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is **MARK'S PAINT & SPRAYDECK, INC.**

**ARTICLE II: DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

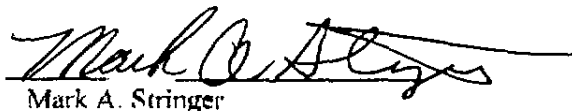
#### **ARTICLE VII: INCORPORATOR**
