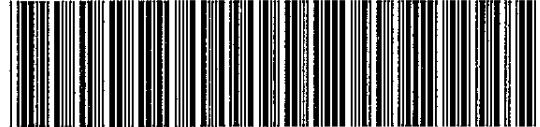

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be RMB TRUCKING & LAND CLEARING, INC.

ARTICLE II - ADDRESS

The street address of the initial registered office of the corporation shall be: 761 Gibbons Rd. SW, Palm Bay, FL 32908

ARTICLE III - NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.
