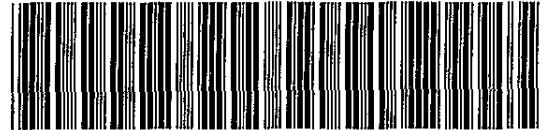

## ARTICLES OF INCORPORATION

OF

EPO SERVICE, Inc.

### ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is EPO SERVICE, Inc. and its principal place of business shall be located at 455 Spike Court, Poinciana Florida, 34759.

### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE IV - CAPITAL STOCK

## ARTICLE X - INDEMNIFICATION






