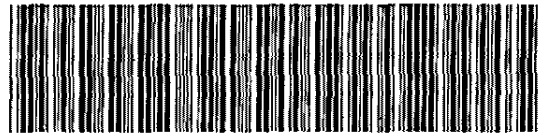

**ARTICLES OF INCORPORATION FOR
SIRA VECIANA-MUÑO, P.A.**

The undersigned, for the purpose of forming a professional service corporation for pecuniary profit under the provisions of Chapters 607 and 621 of the Florida Statutes, hereby makes, subscribes, acknowledges, and files the following Articles of Incorporation:

ARTICLE I

Name

The name of this professional service corporation is SIRA VECIANA-MUÑO, P.A.

ARTICLE II

Duration and Commencement

This corporation shall have a perpetual existence, commencing on the date of the filing of these Articles by the Department of State.

ARTICLE III

Purpose

This professional service corporation shall have the authority to engage in the practice of and the profession of law authorized under the laws of the United States of America and the State of Florida, including, but not limited to, performing any and all acts whatsoever in order to implement the business purpose of this corporation.

ARTICLE IV

Capital Stock

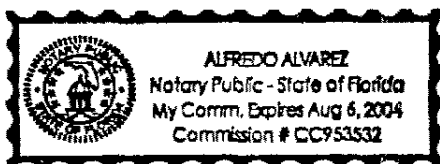
