ARTICLES OF INCORPORATION**OF****BAY SIDE PETROLEUM EQUIPMENT AND MAINTENANCE COMPANY, INC.**

I, **SAMUEL CHEYENNE LIPPENCOTT**, the undersigned, being of full age, do hereby, for the purpose of forming and organizing a corporation for profit under the provisions of the Corporation Laws of the State of Florida, adopt and declare the following Articles of Incorporation covering the existence and organization of the corporation.

ARTICLE I - NAME

The name of this corporation shall be:

BAY SIDE PETROLEUM EQUIPMENT AND MAINTENANCE COMPANY, INC.**ARTICLE II - DURATION**

The existence of this corporation shall begin upon the filing with the Secretary of State's office, and thereafter the existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation, or the objects or purposes of the corporation shall be as follows:

- A. To engage in the general business of and any other lawful business under the corporate laws of the State of Florida.
- B. To own real and personal property necessary for the rendering of the above services.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) per value common stock. Each of the said shares of stock shall entitle the holder thereof to One (1) vote at any meeting of the stockholders. All stock when issued shall be paid for and shall be non-assessable. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than thirty (30) persons.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI - INITIAL BOARD OF DIRECTORS
