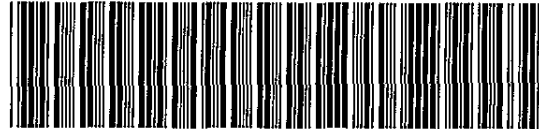

**AMENDMENT TO THE ARTICLES OF INCORPORATION
OF SHELBY HOMES AT THE GROVE, INC.**

In accordance with the provisions of Florida Statutes Sections 607.1003 and 607.1006, SHELBY HOMES AT THE GROVE, INC., a Florida corporation, hereby amends its Articles of Incorporation dated June 7, 2004 and filed on June 9, 2004, as follows:

1. The name of the corporation is SHELBY HOMES AT THE GROVE, INC.
2. The text of the amendment is as follows:

Article IV of the existing Articles of Incorporation of the Corporation, which relates to the capital stock, is hereby deleted in its entirety and the following new Article IV shall be inserted in lieu thereof:

**ARTICLE IV
CAPITAL STOCK**

The capital stock authorized, the par value thereof and the class of such stock shall be as follows:

NO. OF SHARES AUTHORIZED	PAR VALUE PER SHARE	TYPE OF STOCK
1,000	\$1.00	Class A Common Stock
9,000	\$1.00	Class B Common Stock


Holders of Class A Common Stock shall have the same rights and preferences as the holders of the Class B Common Stock, except that the holders of the Class B Common Stock shall have no voting rights whatsoever.

3. The amendment is adopted this 14th day of September, 2005.

4. The Amendment was unanimously adopted by the director and sole shareholder of the Corporation on September 14, 2005.
