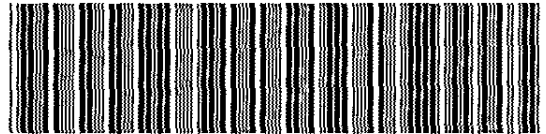

ARTICLES OF INCORPORATION

OF

R & C PLATINUM THERAPY REHAB , INC.

ARTICLE I - NAME

The name of this Corporation is R & C PLATINUM THERAPY REHAB, INC.




