

- I, the undersigned, being a natural person of legal age, do hereby desire to form a Corporation under the Laws of the State of Florida, and do hereby adopt the following Articles of Incorporation.
- NAME. The name of the Corporation shall be US AERO GROUP, INC., a Florida Corporation.
- 2. **PRINCIPAL OFFICE OR MAILING ADDRESS.** The Principal Office of the corporation shall be and its mailing address shall be: P. O. Box 2178, Windermere, Florida 34786. The Principal Office and mailing address may be changed from time to time by the Board of Directors.
- 3. **STOCK.** The maximum number of shares of stock of this Corporation which this Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$.01 per share.
