

TALLAHASSEE, FLORIDA adopts the following Articles of Incorporation for such corporation.

ARTICLE 1 NAME: The name of the corporation shall be Michael Meroles Master Carpentry, Inc.

ARTICLE 2 DURATION: The corporation shall have perpetual existence.

ARTICLE 3 <u>PURPOSE</u>: The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and Florida.
