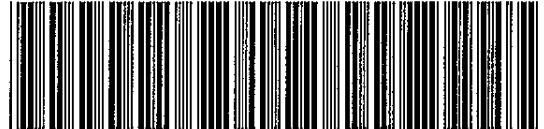

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE 1 NAME : The name of the corporation shall be Michael Merol's Master Carpentry, Inc.

ARTICLE 2 DURATION : The corporation shall have perpetual existence.

ARTICLE 3 PURPOSE : The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and Florida.

ARTICLE 4 CAPITAL STOCK : The corporation is authorized to issue 1000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR per share.

ARTICLE 5 INITIAL REGISTERED OFFICE AND AGENT : The name and address of the initial registered agent and office of the corporation is Michael Merol's whose address is 4700 Kenny Court, Land O' Lakes, FL 34639. This is also the mailing address.

ARTICLE 6 INITIAL BOARD OF DIRECTORS : The corporation shall have one (1) director initially. The number of directors may be increased from time to time by amendment of the bylaws in the manner provided by law, but shall never be less than one (1). The name and address of the person who is to serve as the initial director is Michael Merol's whose address is 4700 Kenny Court, Land O' Lakes, FL 34639.

ARTICLE 7 INCORPORATOR : The name and address of the incorporator is Michael Merol's whose address is 4700 Kenny Court, Land O' Lakes, FL 34639.


ARTICLE 8 BYLAW AMENDMENT : the power to adopt, alter, amend, or repeal the bylaws of the corporation shall be vested in the Board of Directors

ARTICLE 9 INDEMNIFICATION : The corporation shall indemnify any officer, or any former officer or director, to the full extent permitted by law.




