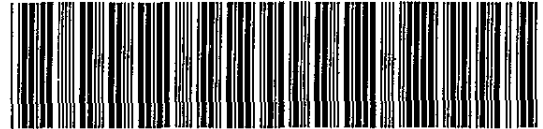

ARTICLES OF INCORPORATION
OF
MISS PASS-A-GRILLE DEEP SEA FISHING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be:

Miss Pass-A-Grille Deep Sea Fishing, Inc.

ARTICLE II - TERM OF EXISTENCE

This corporation shall exist perpetually.



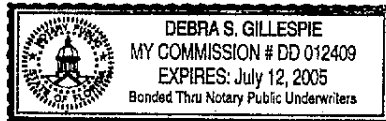
