ARTICLES OF INCORPORATION OF MAB OF SARASOTA, INC.

The undersigned, as incorporator to these Articles of Incorporation, being a natural person competent to contract, hereby files these Articles of Incorporation to form a corporation under Chapter 621 of the Laws of the State of Florida.

ARTICLE I. NAME OF CORPORATION

The name of the corporation shall be: MAB OF SARASOTA, INC.

The address of the principal office of this corporation shall be 1201 Lost Creek Court, Osprey, Florida 34229 and the mailing address of the corporation shall be the same.

ARTICLE II. EFFECTIVE DATE
