

ARTICLES OF INCORPORATION

OF

A1A COUNTY CAB, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE NAME

The name of the corporation is AlA COUNTY CAB, INC.

ARTICLE TWO DURATION
