NAME

The name of this Corporation shall be: OFF DUTY OF PINELLAS, INC

ARTICLE II.

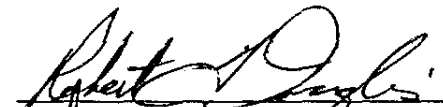
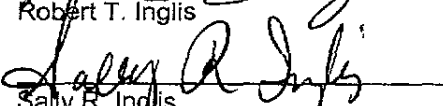
