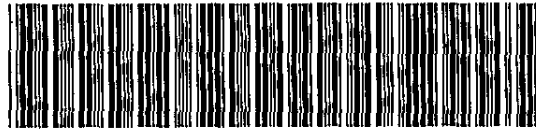

The date of commencement of corporate existence shall be July 1, 2004.

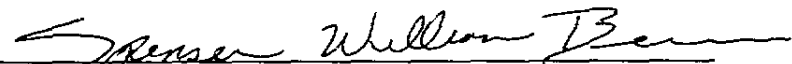
