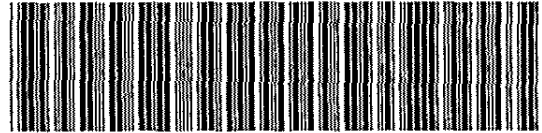

**ARTICLES OF INCORPORATION
FOR
SANBORN WOODWORKS, INC.**

Article I. The Name of the Corporation is Sandborn Woodworks, Inc.

Article II. The initial registered office and the initial principal mailing address of the corporation shall be: 5430 County Fair Court, Oviedo, Florida 32765.

Article III. The corporation is a corporation for profit and is organized for the following general purposes:

(a) To own, lease, conduct and operate a business relating to the design and installation of handcrafted wood cabinetry and furniture.

(b) To do and perform any act or thing not inconsistent with the law relative to the conduct of such a business that may be needful or necessary in its operation;

(c) To engage in any lawful business or activity relating thereto;

(d) To engage in any other lawful business or activity for which corporations may be organized under the Florida Business Corporation Code.

Article IV. The corporation shall have the authority to issue not more than 50,000 shares of common stock having no par value.

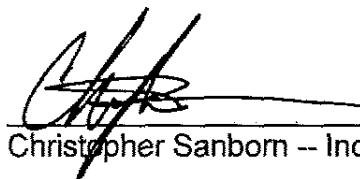

In addition to, but not in limitation of the general powers conferred by law, the corporation shall have the power to make distributions to its shareholders out of its capital surplus; to purchase its own shares out of its reserved and restricted capital surplus available therefor; to initiate and fund a medical reimbursement plan for the employees of the corporation and their families, including but not limited to medical, dental and health plans, and any other such insurance as may in the shareholders' judgment be necessary, and to carry on any other lawful business.

Article IX. This corporation and its shareholders shall have the option and privilege of electing all of the tax provisions commonly referred to as Subchapter S as may be available.

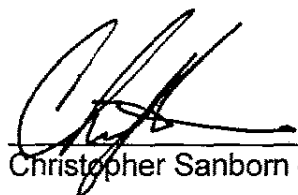
